Sphere of activity

The sphere of activity shall extend to the area served by the Greater Mumbai Municipal Corporation and Navi Mumbai Municipal Corporation.

Membership*

The Sangh shall have the following six categories of members:

1. Ordinary member

(a) Every printing press and other allied industry falling within clause 2 within the area (i.e. Greater Mumbai and Navi Mumbai) can become an ordinary member by paying an entrance fee of Rs. 250 and the appropriate annual subscription as may be fixed by the General Body from time to time.

(b) The annual subscription for ordinary membership is Rs 500 at present.

2. Life member

Any institution entitled to ordinary membership of the Sangh shall become a life member of the Sangh on payment of a minimum amount of Rs. 5000.

3. Patron

Any institution entitled to ordinary membership of the Sangh shall become a patron of the Sangh on payment of a minimum amount of Rs 7500.

4. Honorary member

Persons having sufficient experience of the printing business but who are now no longer active in it and in whose case there is a possibility of the Sangh deriving benefits from their knowledge and experience can be enrolled as honorary members at a meeting of the General Body of the Sangh on recommendation of the Managing Committee.

The number of honorary members shall not exceed five at any one time. The honorary members so enrolled shall not be entitled to be elected to the Managing Committee or as office-bearers.

5. Associate member

Firms/companies, persons engaged in allied trades such as machinery manufacturing, ink manufacturing, offset plate manufacturing, processing, typesetters, canvassers, advertising agencies, publishers etc shall be associate members for life on one time payment of Rs 5000 per year plus Rs 250 as entrance fee. Such members are neither eligible to contest the election of Managing Committee nor can they vote at the meeting.

6. Satellite life members

Printing presses outside the sphere of activity, i.e. Greater Mumbai and Navi Mumbai, can become satellite life members of the Sangh on one time payment of Rs 5000. Such members are neither eligible to contest the election of the Managing Committee nor can vote at the meeting.
